JVN MEMBERSHIP TERMS & CONDITIONS

1. Eligibility for Membership

Your organisation must be a registered charity in the UK. JVN reserves the right to refuse Membership to any charity it believes to be ineligible for Membership. The decision of the JVN Director/Board of Trustees will be final.

2. Membership application

Application for membership can be requested by returning the membership form by email or post. The Membership will start upon receipt of the Membership fee, which is currently £150. At the point of renewal of your Membership, your renewal payment is confirmation of the continued Membership.

3. Professional development and conduct

By taking out JVN Membership you are confirming that, as a JVN member, you will be committed to the development of good practice in volunteer management in your charity.

4. Cancellation and refunds

You will receive a renewal notice and invoice in advance of the anniversary of your last payment date. At that moment you are entitled to cancel further Membership but you must inform us in writing by email or by post. No refunds will be provided during your membership year.

5. Membership fee

The annual Membership fee is currently £150. We reserve the right to increase this fee if we require. You will be informed of any fee increase within your renewal notification. Additional payments will not be claimed during the current Membership period already paid for (aside from fees select additional services – please contact us for details).
